FUND TO THE SERVICE OF THE YEARS ENDING ON
THE THIRTY-FIRST DAY OF MARCH ONE THOUSAND
NINE HUNDRED AND TWENTY-FIVE AND ONE
THOUSAND NINE HUNDRED AND TWENTY-SIX.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT
EIREANN AS FOLLOWS:—

1.—The Minister for Finance may issue out of the Central
Fund and apply towards making good the Supply granted for
the service of the year ending on the thirty-first day of March
one thousand nine hundred and twenty-five the sum of One
Million, One Hundred and Thirty-eight Thousand, Six Hundred
and Seventy-two Pounds.

2.—The Minister for Finance may issue out of the Central
Fund and apply towards making good the supply granted for
the service of the year ending on the thirty-first day of March
one thousand nine hundred and twenty-six the sum of Nine
Million, One Hundred and Fifty-seven Thousand, Eight Hundred
and Thirty-four Pounds.

3.—(1) The Minister for Finance may borrow from any person
and the Bank of Ireland may advance to the Minister for Finance,
on the credit of the said sums any sum or sums not exceeding in
the whole Ten Million, Two Hundred and Ninety-six Thousand,
Five Hundred and Six Pounds, and for the purpose of such
borrowing the Minister for Finance may create and issue any
securities bearing such rate of interest, and subject to such con-
ditions as to repayment, redemption or otherwise as he thinks fit.

(2) The principal and interest of any securities issued under
this Act and the expenses incurred in connection with the issue
of such securities shall be charged on the Central Fund or the
growing produce thereof.

(3) Any money raised by securities issued under this Act shall
be placed to the credit of the account of the Exchequer and shall
form part of the Central Fund and be available in any manner
in which such Fund is available.

4.—This Act may be cited as the Central Fund Act, 1925.
