AN ACT TO APPLY CERTAIN SUMS OUT OF THE CENTRAL FUND TO THE SERVICE OF THE YEARS ENDING ON THE THIRTY-FIRST DAY OF MARCH ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE AND ONE

THOUSAND NINE HUNDRED AND TWENTY-SIX

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:—

1.—The Minister for Finance may issue out of the Central Issue of Fund and apply towards making good the Supply granted for the service of the year ending on the thirty-first day of March cone thousand nine hundred and twenty-five the sum of One Central Fund one thousand nine hundred and twenty-five the sum of One for the service Million, One Hundred and Thirty-eight Thousand, Six Hundred of the year and Seventy-two Pounds.

2.—The Minister for Finance may issue out of the Central Issue of 20 Fund and apply towards making good the supply granted for £9,157,834 the service of the year ending on the thirty-first day of March Central Fund one thousand nine hundred and twenty-six the sum of Nine for the service Million, One Hundred and Fifty-seven Thousand, Eight Hundred of the year and Thirty-four Pounds.

ending 31st March, 1926.

3.—(1) The Minister for Finance may borrow from any person Power of and the Bank of Ireland may advance to the Minister for Finance, on the credit of the said sums any sum or sums not exceeding in Finance to the whole Ten Million, Two Hundred and Ninety-six Thousand, Five Hundred and Six Pounds, and for the purpose of such borrowing the Minister for Finansce may create and issue any securities bearing such rate of interest, and subject to such conditions as to repayment, redemption or otherwise as he thinks fit.

- (2) The principal and interest of any securities issued under this Act and the expenses incurred in connection with the issue 35 of such securities shall be charged on the Central Fund or the growing produce thereof.
- (3) Any money raised by securities issued under this Act shall be placed to the credit of the account of the Exchequer and shall form part of the Central Fund and be available in any manner 40 in which such Fund is available.

4.—This Act may be cited as the Central Fund Act, 1925.
