AN ACT TO APPLY CERTAIN SUMS OUT OF THE CENTRAL FUND TO THE SERVICE OF THE YEARS ENDING ON THE THIRTY-FIRST DAY OF MARCH, ONE THOUSAND NINE HUNDRED AND TWENTY-FOUR AND ONE THOUSAND NINE HUNDRED AND 10 TWENTY-SIX, AND TO APPROPRIATE THE FURTHER SUPPLIES GRANTED IN THIS SESSION OF THE OIREACHTAS.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS :-15

GRANTS OUT OF THE CENTRAL FUND.

of the Central Fund for the service of the 31st March, 1924.

1 .- The Minister for Finance may issue out of the Central Fund and apply towards making good the supply granted for the service of the year ended on the thirty-first day of March, year ended on the one thousand nine hundred and twenty-four, the sum of ten 20 pounds.

> 2 .- The Minister for Finance may issue out of the Central Fund and apply towards making good the supply granted for the service of the year ending on the thirty-first day of March, one thousand nine hundred and twenty-six, the sum of seventeen 25 million, eight hundred and eighty-one thousand, three hundred and thirty-three pounds.

> 3.-(1) The Minister for Finance may borrow from any person and the Bank of Ireland may advance to the Minister for Finance on the credit of the said sum any sum or sums not 30 exceeding in the whole seventeen million, eight hundred and eighty-one thousand, three hundred and forty-three pounds, and for the purpose of such borrowing the Minister for Finance may create and issue any securities bearing such rate of interest and subject to such conditions as to repayment, redemption or other- 35 wise as he thinks fit.

(2) The principal and interest of any securities issued under this Act and the expenses incurred in connection with the issue of such securities shall be charged on the Central Fund or the growing produce thereof.

(3) Any moneys raised by securities issued under this Act shall be placed to the credit of the account of the Exchequer and shall form part of the Central Fund and be available in any manner in which such Fund is available.


