AN ACT TO EXTEND THE LIMIT OF TIME IMPOSED BY THE TRADE LOANS (GUARANTEE) (AMENDMENT) 15
-ACT, 1926, ON THE GIVING OF GUARANTEES AND THE MAKING OF LOANS UNDER THE TRADE LOANS (GUARANTEE) ACT, 1924.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:—

The Principal

1.—In this Act the expression "the Principal Act" means the Trade Loans (Guarantee) Act, 1924 (No. 41 of 1924).

Extension of time for guarantees, etc., under the Principal Act.

- 2.—(1) Sub-section (1) of section 2 of the Trade Loans (Guarantee) (Amendment) Act, 1926 (No. 33 of 1926) is hereby repealed and in lieu thereof it is hereby enacted that no guarantee 25 shall be given under section 1 of the Principal Act after the 31st day of July, 1928.
- (2) Sub-section (2) of section 2 of the said Trade Loans (Guarantee) (Amendment) Act, 1926 is hereby repealed, and in lieu thereof it is hereby enacted that no loan shall be granted and no 30 guarantee shall be given under section 2 of the Principal Act after the 31st day of July, 1928.

Short title and citation.

- 3.—(1) This Act may be cited as the Trade Loans (Guarantee) (Amendment) Act, 1927.
- (2) The Trade Loans (Guarantee) Acts, 1924 to 1926 and this 35 Act may be cited together as the Trade Loans (Guarantee) Acts, 1924 to 1927.
