AN ACT TO APPLY A CERTAIN SUM OUT OF THE CENTRAL FUND TO THE SERVICE OF THE YEAR ENDING ON THE THIRTY-FIRST DAY OF MARCH, ONE THOUSAND NINE HUNDRED AND TWENTY-NINE.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT 20 EIREANN AS FOLLOWS :-

1.—The Minister for Finance may issue out of the Central Issue of Fund and apply towards making good the supply granted for the service of the year ending on the thirty-first day of March one thousand nine hundred and twenty-nine the sum of Seven Milthousand six Hundred the 31st March, 1929. 25 lion Four Hundred and Thirty-Eight Thousand Six Hundred and Thirty-Five Pounds.

2.—(1) The Minister for Finance may borrow from any person and the Bank of Ireland may advance to the Minister for Finance, on the credit of the said sums any sum or sums not exceeding in 30 the whole Seven Million Four Hundred and Thirty-Eight Thousand Six Hundred and Thirty-five Pounds and for the purpose of such borrowing the Minister for Finance may create and issue any securities bearing such rate of interest, and subject to such conditions as to repayment, redemption or otherwise as he thinks fit.

Power of Minister for Finance to

- (2) The principal and interest of any securities issued under this Act and the expenses incurred in connection with the issue of such securities shall be charged on the Central Fund or the growing produce thereof.
- (3) Any money raised by securities issued under this Act shall 40 be placed to the credit of the account of the Exchequer and shall form part of the Central Fund and be available in any manner in which such Fund is available.

3 .- This Act may be cited as the Central Fund (No. 2) Act Short title. 1928.
