BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT  
15 EIREANN AS FOLLOWS:—

1.—Sub-section (2) of Section 1 of the Public Safety Act, 1927  
(No. 31 of 1927), is hereby repealed and in lieu thereof it is here-  
by enacted that the said Public Safety Act, 1927, shall continue  
in force until the 31st day of December, 1928, and shall then  
20 expire.
