ACT, 1923, MAY BE EXERCISED.

20 BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT  
EIREANN AS FOLLOWS:—

1.—Notwithstanding anything to the contrary contained in the  
Civic Guard (Acquisition of Premises) (Amendment) Act, 1928  
(No. 7 of 1928), the power of acquiring premises and the powers  
ancillary thereto conferred on the Commissioners of Public Works  
25 in Ireland by the Civic Guard (Acquisition of Premises) Act,  
1923 (No. 24 of 1923), shall subject to the other provisions of that  
Act, be exercisable until the 16th day of July, 1930, and no  
longer.

2.—(1) This Act may be cited as the Civic Guard (Acquisition  
30 of Premises) (Amendment) Act, 1929.
