AN ACT TO APPLY CERTAIN SUMS OUT OF THE CENTRAL FUND TO THE SERVICE OF THE YEARS ENDING ON THE THIRTY-FIRST DAY OF MARCH ONE THOUSAND NINE HUNDRED AND TWENTY-NINE AND ONE THOUSAND NINE HUNDRED AND THIRTY.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS :-

1 .- The Minister for Finance may issue out of the Central Issue of £530,177 Fund and apply towards making good the supply granted for the service of the year ending on the thirty-first day of March one thousand nine hundred and twenty-nine the sum of Five Hundred and Thirty Thousand One Hundred and Seventy-seven ending the 31st March, 1929. 25 Fund and apply towards making good the supply granted for the Pounds.

2.—The Minister for Finance may issue out of the Central Issue of Fund and apply towards making good the supply granted for the £7,570,125 out service of the year ending on the thirty-first day of March one thousand nine hundred and thirty the sum of Seven Million Five Hundred and Seventy Thousand One Hundred and Twenty-five year ending the 31st March, 1930.

3—(1) The Minister for Finance may borrow from any person and the Bank of Ireland may advance to the Minister for Finance, on the credit of the said sums any sum or sums not exceeding in the whole Eight Million One Hundred Thousand Three Hundred 40 and Two Pounds and for the purpose of such borrowing the Minister for Finance may create and issue any securities bearing such rate of interest, and subject to such conditions as to repayment, redemption or otherwise as he thinks fit.

Power of Minister for Finance to borrow.

- (2) The principal and interest of any securities issued under this 45 Act and the expenses incurred in connection with the issue of such securities shall be charged on the Central Fund or the growing produce thereof.
- (3) Any money raised by securities issued under this Act shall be placed to the credit of the account of the Exchequer and shall 50 form part of the Central Fund and be available in any manner in which such Fund is available.
