15 AN ACT TO CONTINUE THE DEFENCE FORCES (TEMPORARY PROVISIONS) ACTS, 1923 TO 1929.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:—

20 1.—The Defence Forces (Temporary Provisions) Acts, 1923 to 1929, shall continue in force until the 31st day of March, 1931, and shall then expire.

Continuance of the Defence Forces (Temporary Provisions) Acts 1923 to 1929.

2.—(1) This Act may be cited as the Defence Forces (Temporary Provisions) Act, 1930.

Short title, construction and citation.

25 (2) This Act shall be construed as one with the Defence Forces (Temporary Provisions) Acts, 1923 to 1929, and those Acts and this Act may be cited together as the Defence Forces (Temporary Provisions) Acts, 1923 to 1930.
