the expression “the Act of 1923” means the Increase of Rent
and Mortgage Interest (Restrictions) Act, 1923 (No. 19 of 1923),

25 the expression “the Act of 1926” means the Increase of Rent
and Mortgage Interest (Restrictions) Act, 1926 (No. 24 of 1926),

the expression “the Act of 1929” means the Increase of Rent
and Mortgage Interest (Restrictions) Act, 1929 (No. 15 of 1929).

30 2.—Section 4 of the Act of 1926 as amended by section 3 of the
Act of 1929 is hereby amended by the deletion of the words
“until and only until the 24th day of June, 1930.”

3.—Section 2 of the Act of 1929 is hereby repealed and in lieu
thereof it is hereby enacted that the Act of 1923 shall, subject to
the amendments made therein by the Act of 1926 and by this Act,
35 continue in force until the 31st day of December, 1930.

4.—This Act may be cited as the Increase of Rent and Mortgage

40 Interest (Restrictions) Acts, 1923 to 1930.
