15 BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT
 ÉIREANN AS FOLLOWS:—

1.—In this Act the expression “the Principal Act” means the
 Agricultural Produce (Fresh Meat) Act, 1930 (No. 10 of 1930). The Principal

2.—Section 10 of the Principal Act is hereby amended in the

 ingly, that is to say—

(a) by the insertion in sub-section (1) of the said section of
 the word “eighteen” in lieu of the word “twelve”
 where the same first occurs in the said sub-section, and

25 (b) by the deletion in sub-section (4) of the said section of
 the words “and shall not again be provisionally
 registered under this section in such register,” now
 contained therein.

3.—This Act may be cited as the Agricultural Produce (Fresh Short title and

 together as the Agricultural Produce (Fresh Meat) Acts, 1930
