BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT
EIREANN AS FOLLOWS:—

20 1.—(1) In this Act the expression “ the Principal Act ” means The Principal Act.
the Public Charitable Hospitals (Temporary Provisions) Act, 1930
(No. 12 of 1930).

(2) All expressions and words to which a particular meaning
is given by the Principal Act as amended or extended by sub-
sequent enactments have in this Act the meanings so given to
25 them respectively.

2.—Notwithstanding anything to the contrary contained in Condition of disposal of available surplus.
the Principal Act as amended or extended by subsequent enact-
ments no monies shall be payable out of the available surplus
of any sweepstake held after the passing of this Act to any govern-
30 ing body of any hospital which has not provided and will not
undertake to provide to the satisfaction of the Minister for Justice
not less than twenty-five per cent. of its total accommodation for
indoor patients who did not pay for treatment in
such hospital or who paid or on whose behalf there was paid for
35 such treatment payment at a rate not exceeding ten shillings
per week.

3.—(1) This Act may be cited as the Public Charitable Short title, citation, and duration.
Hospitals (Amendment) (No. 2) Act, 1932.

(2) For the purposes of collective citation the expression “ the
40 Public Charitable Hospitals Acts, 1930 to 1932 ” shall include this
Act.

(3) This Act shall remain in force for so long as the Principal
Act continues in force and no longer.
