BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT 20 EIREANN AS FOLLOWS—

- 1.—(1) If and whenever the Minister for Industry and Commerce is satisfied that a company has, whether before or after or partly before and partly after the passing of this Act, erected in one or more places in Saorstát Eireann machinery and plant for the manufacture of cement from cement clinker, the said Minister may at his discretion, by writing sealed with his official seal, undertake with such company that no duty of customs shall be charged or levied on cement clinker imported into Saorstát Eireann after the giving of such undertaking until the 30 expiration of such period (expiring within eleven years reckoned from the passing of this Act) as shall be specified in such undertaking.
- (2) If and whenever the Minister for Industry and Commerce gives any such undertaking as is authorised by the preceding sub-35 section of this section, such undertaking shall have the same force and effect as it would have if the provisions thereof were enacted in and by this Act.
- (3) In this section the word "company" includes a company incorporated by or under the laws of a foreign country, and the 40 expression "cement clinker" means clinker produced by the burning of a mixture of clay and chalk for the purpose of manufacturing cement therefrom.
  - 2.—This Act may be cited as the Cement (Customs Duty Short title. Undertaking) Act, 1932.
