20 BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT
EIREANN AS FOLLOWS:—

- 1.—This Act may be cited as the Summary Jurisdiction Short Title.
(Punishment in cases of Solicitation) Act, 1932.
- 2.—(a) So much of section 14 of the Dublin Police Act, 1842 Imprisonment
as provides penalties for the following offences, that in lieu of
25 is to say, common prostitute or nightwalker loitering or being in any thoroughfare or public place for Penalties for
the purpose of prostitution or solicitation to the Offences of
annoyance of the inhabitants or passengers; and Solicitation.
- (b) so much of section 28 of the Town Police Clauses Act, 1847 as provides penalties for the following offences,
30 that is to say, common prostitute or nightwalker loitering and importuning passengers for the purpose
of prostitution; and
- (c) so much of section 72 of the Towns Improvement
35 (Ireland) Act, 1854 as provides penalties for the following offences, that is to say, common prostitute or
nightwalker loitering or importuning passengers for
the purpose of prostitution or being otherwise offen-
sive;
- 40 are hereby respectively repealed and in lieu thereof every person
guilty of any of the said offences shall be liable to imprisonment
with or without hard labour for any term not exceeding six
months.
- 3.—The Probation of Offenders Act, 1907 shall apply to the Application

pects of the moral reclamation of the person or persons charged" of Offenders
were inserted in sub-section (1) of section 1 thereof immediately Act, 1907.
