# BILL

*entitled*

AN ACT TO CONTINUE FOR A LIMITED PERIOD  
CERTAIN EXPIRING ENACTMENTS.

15 BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT  
EIREANN AS FOLLOWS:—

1.—(1) The Acts mentioned in the Schedule to this Act shall, to the extent specified in the third column of the said Schedule, be continued until the 31st day of December, 1933, and shall then 20 expire unless further continued.

(2) Any unrepealed enactments amending or affecting the enactments continued by this section shall, in so far as they are temporary in their duration, be continued in like manner whether they are mentioned in the Schedule to this Act or not.

25 2.—This Act may be cited as the Expiring Laws Act, 1932. Short title.
