**AN ACT TO EXTEND THE PUBLIC CHARITABLE
HOSPITALS (TEMPORARY PROVISIONS) ACT, 1930,
SO AS TO APPLY TO A CERTAIN HOSPITAL.**

**BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT
20 EIREANN AS FOLLOWS :—**

1.—(1) In this Act the expression "the Principal Act" means **The Principal
the Public Charitable Hospitals (Temporary Provisions) Act, 1930 Act.
(No. 12 of 1930).**

25 (2) All expressions and words to which a particular meaning
is given by sub-section (1) of section 1 of the Principal Act have
in this Act the meanings so given to them respectively.

30 **2.—**Notwithstanding anything contained in sub-section (2) of
section 1 of the Principal Act, that Act shall extend and apply to
the following hospital, that is to say, the Royal National Hospital
for Consumption, Newcastle, Co. Wicklow. **Extension of
the Principal
Act to a certain
hospital.**

35 **3.—**This Act shall not apply or have effect in relation to any
scheme which has been sanctioned under the Principal Act by the
Minister before the passing of this Act or to any sweepstake held
under the Principal Act, whether before or after the passing of
this Act, in pursuance of a scheme so sanctioned. **Application of
this Act.**

4.—(1) This Act may be cited as the Public Charitable
Hospitals (Amendment) Act, 1932. **Short title,
citation, and
duration.**

40 (2) This Act shall be construed as one with the Public
Charitable Hospitals Acts, 1930 and 1931, and those Acts and this
Act shall be cited together as the Public Charitable Hospitals Acts,
1930 to 1932.

(3) This Act shall remain in force for so long as the Principal
Act continues in force and no longer.
