AN ACT TO AMEND SECTION 12 OF THE LOCAL GOVERN-MENT ACT, 1927.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT 20 EIREANN AS FOLLOWS:-

1.—Paragraph (c) of sub-section (2) of section 12 of the Local Partial repeal of Government Act, 1927 (No. 3 of 1927), is hereby repealed as on and from the 1st day of April, 1933, and the said section shall Local Government Act, 1927. 25 date effect accordingly.
