AN ACT TO INCREASE THE TOTAL AMOUNT OF THE SUMS WHICH MAY BE ADVANCED TO THE
15 ELECTRICITY SUPPLY BOARD UNDER THE ELECTRICITY (SUPPLY) (AMENDMENT) ACT, 1931.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:—

20 **1.**—Sub-section (2) of section 3 of the Electricity (Supply) (Amendment) Act, 1931 (No. 32 of 1931), and section 4 of the Electricity (Supply) (Amendment) Act, 1932 (No. 15 of 1932), are hereby repealed and in lieu thereof it is hereby enacted that the total amount of the sums advanced to the Electricity Supply Board under the said section 3 of the said Electricity (Supply) (Amendment) Act, 1931, shall not exceed the sum of three million
25 five hundred and twenty-five thousand pounds.

Limit of advances under the Electricity (Supply) (Amendment) Act, 1931.

2.—(1) This Act may be cited as the Electricity (Supply) (Amendment) Act, 1934.

Short title and citation.

(2) The Electricity (Supply) Acts, 1927 to 1932, and this Act
