BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:—

1.—In this Act—

- the expression “the Principal Act” means the Offences Against
20 the State (Forfeiture) Act, 1940 (No. 27 of 1940).

- 2.—Section 2 of the Offences Against the State (Forfeiture) Act, 1941 (No. 21 of 1941), is hereby repealed, and in lieu thereof it is hereby enacted that each of the two references to the 3rd day of September, 1941, contained in sub-section (1) of section 2 of
25 the Principal Act, shall be construed as a reference to the 3rd day of September, 1943.

- 3.—(1) This Act may be cited as the Offences Against the State (Forfeiture) Act, 1942.
