# BILL

15 AN ACT TO APPLY THE SEEDS AND FERTILISERS  
SUPPLY ACT, 1942, TO THE PERIOD WHICH BEGAN  
ON THE 1ST DAY OF AUGUST, 1944, AND WILL END  
ON THE 31ST DAY OF JULY, 1947, AND TO VALIDATE  
20 CERTAIN ORDERS MADE, SANCTIONS GIVEN, AND  
THINGS DONE BEFORE THE PASSING OF THIS ACT.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

- 1.—In this Act, the expression “ the Principal Act ” means the  
Seeds and Fertilisers Supply Act, 1942 (No. 11 of 1942). The Principal Act.
- 2.—The Principal Act shall apply to the period which began  
25 on the 1st day of August, 1944, and will end on the 31st day of  
July, 1947, in like manner as it applied to the period which began  
on the 1st day of August, 1941, and ended on the 31st day of July,  
1942, and the expression “ the period to which this Act applies ”  
shall throughout the Principal Act be construed and have effect  
30 accordingly. Application of Principal Act to period which began on 1st August, 1944, and will end on 31st July, 1947.
- 3.—All orders made, sanctions given, and things done by the  
Minister for Local Government and Public Health before the pass-  
ing of this Act in relation to the provision and sale of goods under  
the Principal Act as applied by this Act by the councils of counties  
35 or in relation to the making and carrying out by the councils of  
counties of schemes authorised by the Principal Act as applied by  
this Act for the giving of guarantees by such councils shall be  
and shall be deemed always to have been legal and valid for all  
purposes. Validation of certain orders.
- 4.—This Act may be cited as the Seeds and Fertilisers Supply  
40 Act, 1945. Short title.
