AN ACT TO APPLY A CERTAIN SUM OUT OF THE CENTRAL FUND TO THE SERVICE OF THE YEAR ENDING ON THE THIRTY-FIRST DAY OF MARCH, ONE THOUSAND NINE HUNDRED AND FORTY-SEVEN, AND TO APPROPRIATE TO THE PROPER 10 SUPPLY SERVICES AND PURPOSES THE SUMS GRANTED BY THE CENTRAL FUND ACT, 1946, AND THIS ACT.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:-

GRANTS OUT OF THE CENTRAL FUND.

15

Issue of £36,211,178 out of the Central Fund for the year 1946-47.

1.—The Minister for Finance may issue out of the Central Fund and apply towards making good the supply granted for the service of the year ending on the thirty-first day of March, one thousand nine hundred and forty-seven, the sum of thirty-six million, two hundred and eleven thousand, one hundred and 20 seventy-eight pounds.

Power of the Minister for Finance to borrow up to £36,211,178.

2.—(1) The Minister for Finance may borrow from any person and the Bank of Ireland may advance to the Minister for Finance any sum or sums not exceeding in the whole thirty-six million, two hundred and eleven thousand, one hundred and seventy-eight 25 pounds, and for the purpose of such borrowing the Minister for Finance may create and issue any securities bearing such rate of interest and subject to such conditions as to repayment, redemption or otherwise as he thinks fit.

(2) The principal and interest of any securities issued under 30 this Act and the expenses incurred in connection with the issue of such securities shall be charged on the Central Fund or the growing produce thereof.

(3) Any moneys raised by securities issued under this Act shall be placed to the credit of the account of the Exchequer and shall form part of the Central Fund and be available in any manner in which such Fund is available.

APPROPRIATION OF GRANTS.

Appropriation of sums voted for supply services, viz., £53,716,664.

3 .- (1) All sums granted by this Act and the other Act mentioned in Schedule (A) annexed to this Act out of the Central Fund 40 towards making good the supply granted, amounting, as appears by the said Schedule, in the aggregate to the sum of fifty-three

million, seven hundred and sixteen thousand, six hundred and sixtyfour pounds, are appropriated and shall be deemed to have been
appropriated as from the date of the passing of the Acts mentioned in the said Schedule (A) for the services and purposes
5 expressed in Schedule (B) annexed thereto. The abstract of
schedules and schedules annexed thereto, with the note (if any) to
such schdules shall be deemed to be part of this Act in the same
manner as if they had been contained in the body thereof.

(2) In addition to the grants out of the Central Fund referred to in the foregoing subsection of this section, there may be applied out of any money directed under section 2 of the Public Accounts and Charges Act, 1891, to be applied as appropriations-in-aid of the grants for the services and purposes specified in Schedule (B) annexed hereto, the sums respectively set forth in the last column 15 of the said Schedule amounting, as appears thereby, in the aggregate to the sum of three million, one hundred and sixty thousand, six hundred and sixty-four pounds.

4.—This Act may be cited as the Appropriation Act, 1946.
