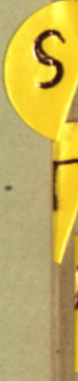

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

- 1.—The following subsection shall be substituted for subsection (2) of section 1 of the Road Fund (Advances) Act, 1926 (No. 29 of 1926) :—
  - 20 “ (2) The total amount of the sums advanced to the Road Fund under this section shall not exceed the sum of five million pounds.”
- 2.—(1) This Act may be cited as the Road Fund (Advances) Act, 1948.
- 25 (2) The Road Fund (Advances) Act, 1926 (No. 29 of 1926), and this Act may be cited together as the Road Fund (Advances) Acts, 1926 and 1948.
