BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

- 1.—In this Act, “the Principal Act” means the Supplies and The Principal

- 2.—(1) The Principal Act shall, unless previously terminated Continuance
under subsection (2) of this section, continue in force until the of the
31st day of December, 1950, and shall then expire unless the Principal Act.

- 25 (2) The Government may by order declare that the Principal
Act shall expire on a specified date, being earlier than the 31st day
of December, 1950, and in that case the Principal Act shall expire
accordingly.
- 3.—The Supplies and Services (Temporary Provisions) Act, Repeal.
