15 AN ACT TO EXTEND THE PERIOD DURING WHICH THE SUPPLIES AND SERVICES (TEMPORARY PROVISIONS) ACT, 1946, CONTINUES IN FORCE.

#### BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :-

- 1.- In this Act, "the Principal Act" means the Supplies and The Principal 20 Services (Temporary Provisions) Act, 1946 (No. 22 of 1946). Act.
  - 2.—(1) The Principal Act shall, unless previously terminated Continuance under subsection (2) of this section, continue in force until the of the 31st day of December, 1950, and shall then expire unless the Principal Act. Oireachtas otherwise determines.
- (2) The Government may by order declare that the Principal Act shall expire on a specified date, being earlier than the 31st day of December, 1950, and in that case the Principal Act shall expire accordingly.
- 3.—The Supplies and Services (Temporary Provisions) Act, Repeal. 30 1946 (Continuance) Act, 1948 (No. 18 of 1948), is hereby repealed.
  - 4 .- This Act may be cited as the Supplies and Services (Tem- Short title. porary Provisions) Act, 1946 (Continuance) Act, 1949.
