AN ACT TO CONFIRM AN ORDER MADE UNDER THE EMERGENCY IMPOSITION OF DUTIES ACT, 1932.

15 BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:-

1.—(1) The Order mentioned in the second column of the Confirmation of Schedule to this Act, and made under the Emergency Imposition Order. of Duties Act, 1932 (No. 16 of 1932), is hereby confirmed.

(2) The particulars stated in the first and third columns, 20 respectively, of the Schedule to this Act in relation to the Order mentioned in the second column of that Schedule are inserted solely to facilitate reference to and identification of the said Order, and, accordingly, nothing contained in the said first column or the said third column shall affect the construction or limit or control the 25 operation of this section and the second column of the said Schedule.

2.—This Act may be cited as the Imposition of Duties (Confirma- Short Title. tion of Order) Act, 1950.
