1.-In this Act-

- 20 "the Principal Act " means the Supplies and Services (Temporary Provisions) Act, 1946 (No. 22 of 1946); "the Act of 1950" means the Supplies and Services (Temporary Provisions) Act, 1946 (Continuance and Amendment) Act, 1950
- 2.-(1) The Principal Act shall, unless previously terminated Continuance 25 under subsection (2) of this section, continue in force until the of the

Principal Act.

(2) The Government may by order declare that the Principal Act shall expire on a specified date, being earlier than the 31st 30 day of December, 1952, and in that case the Principal Act shall expire accordingly.

3.-Section 2 of the Act of 1950 is hereby repealed.

Repeal of section 2 of the Act of 1950. Short title, collective citation and construction.

4.-(1) This Act may be cited as the Supplies and Services (Temporary Provisions) Act, 1946 (Continuance) Act, 1951.

(2) The Principal Act, the Act of 1950 and this Act may be 35 cited together as the Supplies and Services (Temporary Provisions) Acts, 1946 to 1951.

(3) The Principal Act, the Act of 1950 and this Act shall be construed together as one Act.
