AN ACT TO EXTEND THE PERIOD DURING WHICH THE
SUPPLIES AND SERVICES (TEMPORARY PROVI-
SIONS) ACT, 1946, CONTINUES IN FORCE.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

- 20 1.—In this Act, “the Principal Act” means the Supplies and Services (Temporary Provisions) Act, 1946 (No. 22 of 1946). The Principal Act.
- 2.—(1) The Principal Act shall, unless previously terminated under *subsection* (2) of this section, continue in force until the 31st day of December, 1953. Continuance of the Principal Act.
- 25 (2) The Government may by order declare that the Principal Act shall expire on a specified date, being earlier than the 31st day of December, 1953, and in that case the Principal Act shall expire accordingly.
- 3.—The Supplies and Services (Temporary Provisions) Act, 1946 Repeal.
- 30 (Continuance) Act, 1951 (No. 27 of 1951), is hereby repealed.
- 4.—(1) This Act may be cited as the Supplies and Services (Temporary Provisions) Act, 1946 (Continuance) Act, 1952. Short title, construction and collective citation.
- (2) The Principal Act, the Supplies and Services (Temporary Provisions) Act, 1946 (Continuance and Amendment) Act, 1950 35
(No. 34 of 1950), and this Act shall be construed together as one Act and may be cited together as the Supplies and Services (Temporary Provisions) Acts, 1946 to 1952.
