15 AN ACT TO EXTEND THE PERIOD DURING WHICH
THE SUPPLIES AND SERVICES (TEMPORARY PRO-
VISIONS) ACT, 1946, CONTINUES IN FORCE.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

- 1.—In this Act, “the Principal Act” means the Supplies and
20 Services (Temporary Provisions) Act, 1946 (No. 22 of 1946). The Principal

- 2.—(1) The Principal Act shall, unless previously terminated
under *subsection* (2) of this section, continue in force until the 31st
day of March, 1955. Continuance
of the
Principal
Act.
- (2) The Government may by order declare that the Principal Act
25 shall expire on a specified date, being earlier than the 31st day of
March, 1955, and in that case the Principal Act shall expire
accordingly.
- 3.—The Supplies and Services (Temporary Provisions) Act, 1946
(Continuance) Act, 1952 (No. 30 of 1952), is hereby repealed. Repeal.
- 30 4.—(1) This Act may be cited as the Supplies and Services
(Temporary Provisions) Act, 1946 (Continuance) Act, 1953. Short title,
construction
and

citation.
- (2) The Principal Act, the Supplies and Services (Temporary
Provisions) Act, 1946 (Continuance and Amendment) Act, 1950
(No. 34 of 1950), and this Act shall be construed together as one

(Temporary Provisions) Acts, 1946 to 1953.
