15 AN ACT TO EXTEND THE PERIOD DURING WHICH THE SUPPLIES AND SERVICES (TEMPORARY PRO-VISIONS) ACT, 1946, CONTINUES IN FORCE. BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:-

1 .- In this Act, "the Principal Act" means the Supplies and The Principal 20 Services (Temporary Provisions) Act, 1946 (No. 22 of 1946).

2 .- (1) The Principal Act shall, unless previously terminated Continuance under subsection (2) of this section, continue in force until the 31st day of March, 1955.

- (2) The Government may by order declare that the Principal Act 25 shall expire on a specified date, being earlier than the 31st day of March, 1955, and in that case the Principal Act shall expire accordingly.
 - 3.—The Supplies and Services (Temporary Provisions) Act, 1946 Repeal. (Continuance) Act, 1952 (No. 30 of 1952), is hereby repealed.
- 4.—(1) This Act may be cited as the Supplies and Services (Temporary Provisions) Act, 1946 (Continuance) Act, 1953.
