AN ACT TO AMEND THE ALGINATE INDUSTRIES (IRELAND) LIMITED (ACQUISITION OF SHARES) ACT, 1949.

### BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:-

1 .- In this Act "the Principal Act" means the Alginate Principal Industries (Ireland) Limited (Acquisition of Shares) Act, 1949 Act. 20 (No. 22 of 1949).

2.—Subsection (1) of section 2 of the Principal Act (which Amendment of Principal empowers the Minister for Lands to expend a sum or sums not Act. exceeding five thousand one hundred pounds in the acquisition of shares in Alginate Industries (Ireland) Limited) is hereby amended 25 by the substitution of "forty-three thousand pounds" for "five thousand one hundred pounds ".

3.—(1) This Act may be cited as the Alginate Industries (Ireland) Limited (Acquisition of Shares) Act, 1954.

Short title and collective citation.

(2) The Principal Act and this Act may be cited together as 30 the Alginate Industries (Ireland) Limited (Acquisition of Shares) Acts, 1949 and 1954.
