BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

Increase of limit on advances to An Bord Iascaigh Mhara out of the Central Fund.	1.—Subsection (1) of section 18 of the Sea Fisheries Act, 1952 (No. 7 of 1952) (which provides for advances not exceeding in the aggregate five hundred thousand pounds out of the Central Fund to An Bord Iascaigh Mhara) is hereby amended by the substitu- tion of “one million pounds” for “five hundred thousand pounds”.	10
