**BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—**

**1.**—The words “Except where the bridge order relates to the 10  
River Shannon” contained in subsection (4) of section 52 of the  
Local Government Act, 1946 (which subsection was inserted in  
that section by subsection (1) of section 40 of the Local Govern-  
ment Act, 1955) are hereby repealed.

**2.**—The Athlone Bridge Order, 1956, shall have effect as if 15  
Articles 2 and 3 thereof were deleted and the following Article  
were substituted for Article 2 :

“2. The bridge shall be reconstructed by the provision of a  
new fixed span in place of the existing swivel span.”

**3.**—(1) This Act may be cited as the Local Government Act, 20  
1959.

(2) The Local Government Acts, 1925 to 1958, and this Act  
may be cited together as the Local Government Acts, 1925 to  
1959.
