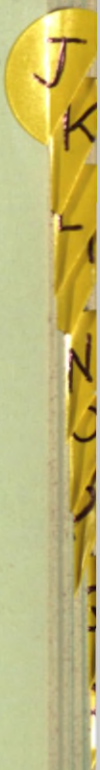

AN ACT TO AMEND THE IRISH SHIPPING LIMITED

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

1.—(1) In this Act “the Principal Act” means the Irish
Shipping Limited Act, 1947.

(2) This Act shall be construed as one with the Principal Act.

2.—Subsection (1) of section 2 of the Principal Act (which
imposes a limit of £5,000,000 on the capital of the Company) is
hereby amended by the substitution of “£12,000,000” for
“£5,000,000”.

3.—Subsection (2) of section 9 of the Principal Act (which
imposes a limit of £2,000,000 on the guarantee by the Minister of
the repayment of moneys borrowed by the Company) is hereby
amended by the substitution of “£5,000,000” for “£2,000,000”.

4.—Section 10 of the Principal Act (which authorises the pay-
ment of subsidies to the Company) is hereby repealed.
