AN ACT TO AMEND THE LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) ACT, 1963.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

Interpretation.

1.—In this Act the “ Principal Act ” means the Local Government (Planning and Development) Act, 1963. 10

**Amendment of
section 35 of
Principal Act.**

2.—Section 35 of the Principal Act is hereby amended by the addition of the following subsection—

“ (10) The provisions of this section shall apply in respect of works of whatsoever kind (which shall include the acquisition and development of open spaces) whether commenced before or after the passing of this Act.” 15

**Short title,
construction and
collective citation.**

3.—(1) This Act may be cited as the Local Government (Planning and Development) (Amendment) Act, 1966.

(2) The Principal Act and this Act shall be construed together as one Act and may be cited together as the Local Government (Planning and Development) Acts, 1963 to 1966. 20
