AN ACT TO APPROPRIATE TO THE PROPER SUPPLY 5 SERVICES AND PURPOSES THE SUMS GRANTED BY THE CENTRAL FUND (PERMANENT PROVISIONS) ACT, 1965.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:-

APPROPRIATION OF GRANTS

Appropriation of sums voted for supply services, viz., £278,977,700. 1.—(1) All sums granted by the Act mentioned in Schedule A annexed to this Act out of the Central Fund towards making good the supply granted, amounting, as appears by the said Schedule, in the aggregate to the sum of two hundred and seventy-eight million, nine hundred and seventy-seven thousand, seven hundred pounds, are appropriated for the services and purposes expressed in Schedule B annexed thereto.

(2) In addition to the grants out of the Central Fund referred to in the foregoing subsection of this section, there may be applied out of any money directed under section 2 of the Public Accounts 20 and Charges Act, 1891, to be applied as appropriations-in-aid of the grants for the services and purposes specified in Schedule B annexed hereto, the sums respectively set forth in the last column of the said Schedule amounting, as appears thereby, in the aggregate to the sum of twenty million, two hundred and three thousand, eight 25 hundred and ninety-one pounds.

Short title.

2.-This Act may be cited as the Appropriation Act, 1967.
