BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS: 10

1.—Where a judge of the Supreme Court who was appointed
on the 6th day of October, 1966, vacates his office on the 26th day of
March, 1978, he shall be deemed for the purposes of Part I of the
Second Schedule to the Courts (Supplemental Provisions) Act, 1961,
to have vacated his office after fifteen years' service. 15
