1. Amount of grants by An Foras Tionscal.

1-17 The aggregate amount of grants made by the Industrial Development Authority under the Industrial Grants Act, 1958, and of grants (other than grants made under section 12 of the Industrial Grants Act, 1958) made by An Foras Tionscal and the Minister for Industry and Commerce under the Industrial Grants Act, 1958 to 1968, and the Industrial Grants Act, 1959 to 1968, and of payments made by An Foras Tionscal and the said Minister on foot of grants given by An Foras Tionscal and the said Minister under the Industrial Grants Act, 1958, shall not exceed forty million pounds.

(2) The aggregate amount of grants made under section 12 of the Industrial Grants Act, 1958, and section 7 of the Industrial Grants Act, 1959, shall not exceed forty million pounds.

2-17 This Act may be cited as the Industrial Grants (Amendment) Act, 1968.

(3) The collective citation the Industrial Grants Act, 1958 to 1968, shall include this Act, and the collective citation the Industrial Grants Act, 1959 to 1968, shall include this Act.

1.—(1) The aggregate amount of grants made by the Industrial Development Authority under the Industrial Grants Act, 1956, and of 10 grants (other than grants under section 12 of the Undeveloped Areas Act, 1952) made by An Foras Tionscal and the Minister for Industry and Commerce under the Undeveloped Areas Acts, 1952 to 1968, and the Industrial Grants Acts, 1959 to 1968, and of payments made by An Foras Tionscal and the said Minister on foot of guarantees 15 given by An Foras Tionscal and the said Minister under the Industrial Grants Act, 1959, shall not exceed forty million pounds.

(2) The aggregate amount of grants under section 12 of the Undeveloped Areas Act, 1952, and section 3 of the Industrial Grants Act, 1956, shall not exceed forty million pounds. 20

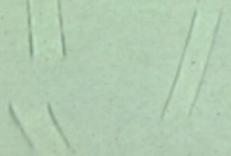
