Amendment of section 9 of the National Building Agency Limited Act, 1963. 1963, No. 32.

Short title and collective citation.

1.—Section 9 of the National Building Agency Limited Act, 1963, is hereby amended by the substitution of "five million pounds" for "two million pounds".

2.—(1) This Act may be cited as the National Building Agency Limited (Amendment) Act, 1969.

(2) The National Building Agency Limited Act, 1963, and this Act may be cited together as the National Building Agency Limited Acts, 1963 and 1969.
