BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

1.—Section 3 (2) of the International Development Association Act, 1960, is hereby amended by the insertion after paragraph (c) of the following paragraph:

“(cc) payments to the Association not exceeding in aggregate 15
the equivalent in Irish currency of 4 million United States
dollars of the weight and fineness in effect on the 1st day
of January, 1960, in accordance with any arrangements
made between the Government and the Association
arising out of any Resolution of the Board of Governors 20
of the Association on additional financial resources.”.

2.—(1) This Act may be cited as the International Development Association (Amendment) Act, 1971.

(2) The International Development Association Act, 1960, and this Act may be cited together as the International Development Association Acts, 1960 and 1971. 25
