BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

1.—Section 13 of the Criminal Procedure Act, 1967 is hereby amended by the insertion after subsection (2) of a new subsection as follows:

“(2A) The Court of Criminal Appeal shall have jurisdiction to remit or to reduce or to increase or otherwise vary a sentence imposed by a court under the procedure provided for in subsection 2 (b).”

2.—(1) This Act may be cited as the Criminal Procedure (Amendment) Act, 1973.

(2) The Criminal Procedure Act, 1967 and this Act may be cited together as the Criminal Procedure Acts, 1967 and 1973.
