SERVICES AND PURPOSES SUMS GRANTED BY THE
CENTRAL FUND (PERMANENT PROVISIONS) ACT, 1965.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS :—

1.—(1) The sums granted by the Central Fund (Permanent Pro-
visions) Act, 1965, out of the Central Fund towards making good ¹⁰
the supply granted, amounting in the aggregate to the sum of seven
hundred and ninety-one million, three hundred and sixty-two
thousand, eight hundred and forty pounds and comprising the sum of
forty-seven million, four hundred and eighty-nine thousand, eight ¹⁵
hundred and forty pounds for the service of the year ended on the
31st day of March, 1973, and the sum of seven hundred and forty-
three million, eight hundred and seventy-three thousand pounds for
the service of the year ending on the 31st day of March, 1974, are
appropriated for the services and purposes expressed in the Schedule ²⁰
annexed hereto.
