BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

1.—(1) Section 2 of the Agriculture (Amendment) Act, 1958, is
hereby amended by the substitution for subsection (1) (inserted by the
Agriculture (Amendment) Act, 1971) of the following subsection: 10

“(1) The council of a county shall, in the local financial year
beginning on the 1st day of January, 1975, and every subsequent
local financial year, make to the committee of agriculture for the
county a contribution under this subsection of not less than the
produce of a rate in the preceding local financial year of one new 15
penny in the pound in the area consisting of the county exclusive
of every (if any) urban district therein and not more than forty
times such produce.”.

(2) All acts and things done before the 1st day of January, 1975,
by the council of a county in relation to the making of any rate for 20
the local financial year beginning on that day shall be as valid and
effectual as if this Act had been in force at the time those acts or
things were done.

2.—(1) This Act may be cited as the Agriculture (Amendment)

(2) The Agriculture Acts, 1931 to 1971, and this Act may be cited
