AN ACT TO AMEND AND EXTEND THE INDUSTRIAL 5  
CREDIT ACTS, 1933 TO 1971.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Interpretation.

1.—(1) In this Act—

“the Act of 1971” means the Industrial Credit (Amendment) 10  
Act, 1971;

“the Principal Act” means the Industrial Credit Act, 1933.

(2) The Industrial Credit Acts, 1933 to 1971, and this Act shall

2.—Paragraph 4 of the Schedule to the Principal Act is hereby  
amended by the substitution in subparagraph (d) (i) (inserted by 15

3.—Section 3 of the Industrial Credit (Amendment) Act, 1958,  
is hereby amended by the substitution in subsection (3) of  
“£75,000,000” for “£30,000,000” (inserted by section 7 of the 20  
Act of 1971).

4.—The Company shall take such steps as may be necessary  
under the Companies Act, 1963, to alter the Memorandum and  
Articles of Association of the Company to make them consistent with  
the Industrial Credit Acts, 1933 to 1974. 25
