ARRANGEMENT OF SECTIONS

Section

1. Interpretation.
2. Elections of certain conservators postponed.
3. Short title, collective citation and construction.

2.—(1) Notwithstanding anything contained in the Fisheries Act, 1959 to 1964, the following provisions shall have effect:

(a) the elections of conservators pursuant to sections 22 and 23 of the Principal Act which, apart from this section, would fall to be held in the year 1974 shall be held instead either in the year 1972 or in such later year as the Minister, if he thinks fit, by order fixes.

(b) the elections of conservators pursuant to those sections other than the elections mentioned in paragraph (a) of this subsection, shall be held in each fifth successive year after the year in which the elections so mentioned are held, and

(c) election year shall be construed in accordance with paragraph (a) and (b) of this subsection.

(2) When an order under this section is proposed to be made, the Minister shall cause a draft of the order to be laid before each House of the Oireachtas and the order shall not be made until a resolution approving of the draft has been passed by each House.

3.—(1) This Act may be cited as the Fisheries (Amendment) Act, 1974.

(2) The Fisheries Act, 1959 to 1964, and this Act may be cited together as the Fisheries Act, 1959 to 1974.

(3) The Principal Act and this Act shall be construed together as one.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Interpretation.

1.—In this Act “the Principal Act” means the Fisheries
(Consolidation) Act, 1959.

2.—(1) Notwithstanding anything contained in the Fisheries Acts, 10
1959 to 1964, the following provisions shall have effect:

(a) the elections of conservators pursuant to sections 22 and 27
of the Principal Act which, apart from this section, would
fall to be held in the year 1974 shall be held instead
either in the year 1975 or in such later year as the 15
Minister, if he thinks fit, by order fixes,

(b) the elections of conservators pursuant to those sections,
other than the elections mentioned in *paragraph (a)* of
this subsection, shall be held in each fifth successive year
after the year in which the elections so mentioned are 20
held, and

(c) election year shall be construed in accordance with *para-*
graphs (a) and (b) of this subsection.

(2) When an order under this section is proposed to be made, the
Minister shall cause a draft of the order to be laid before each House 25
of the Oireachtas and the order shall not be made until a resolution
approving of the draft has been passed by each such House.

3.—(1) This Act may be cited as the Fisheries (Amendment) Act,
1974.

(2) The Fisheries Acts, 1959 to 1964, and this Act may be cited 30
together as the Fisheries Acts, 1959 to 1974.
