1.—The following subsection is hereby substituted for section 2 (2) of the Exchange Control Act, 1954, as amended by section 1 of the Exchange Control (Continuance) Act, 1970:

"(2) This Act shall continue in operation until the 31st day of December, 1978, and shall then expire."

- 2.—(1) This Act may be cited as the Exchange Control (Continuance) Act, 1974.
- (2) The Exchange Control Acts, 1954 to 1970, and this Act may 15 be cited together as the Exchange Control Acts, 1954 to 1974.
