**BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:**

**1.—Section 1 of the Local Loans Fund (Amendment) Act, 1972, is hereby repealed and in lieu thereof it is hereby enacted that the aggregate amount of the moneys issued from the local loans fund in respect of local loans during the period mentioned in section 4 (3) of the Local Loans Fund Act, 1935, shall not exceed the sum of one thousand million pounds.** 10

**2.—(1) This Act may be cited as the Local Loans Fund (Amendment) Act, 1974.** 15
