AN ACT TO AMEND AND EXTEND THE RATES ON
AGRICULTURAL LAND (RELIEF) ACTS, 1939 TO 1974.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

1.—The Rates on Agricultural Land (Relief) Act, 1946, shall
apply to the local financial years ending on the 31st day of 10
December, 1976, and the 31st day of December, 1977, and shall so
apply subject to the modification that no employment allowance
under section 7 shall be made.

certain lands in
urban areas.

2.—(1) Where after the passing of this Act the boundary of a 15
county borough, borough or urban district is extended so as to in-
clude hereditaments of agricultural land which before the extension
formed part of a county health district, the allowances provided
under the Rates on Agricultural Land (Relief) Acts, 1939 to 1976,
shall, subject to *subsection 2* of this section, be made to occupiers 20
of such hereditaments by the local authority whose boundary has
been so extended, and such portion of the agricultural grant as may
be necessary to enable that authority to make such allowances with-
out loss to itself shall be paid by the Minister for Finance to the
authority.

(2) *Subsection (1)* of this section shall apply to a hereditament 25
only for so long as it continues to be used solely or mainly for
agricultural purposes, that is to say, as arable, meadow or pasture
ground or as woodlands, market gardens or nursery grounds.
