AN ACT TO AMEND AND EXTEND THE OLD AGE PEN- 5  
SIONS ACTS, 1908 TO 1974, THE UNEMPLOYMENT  
ASSISTANCE ACTS, 1933 TO 1974, THE WIDOWS' AND  
ORPHANS' PENSIONS ACTS, 1935 TO 1974, THE SOCIAL  
WELFARE (CHILDREN'S ALLOWANCES) ACTS, 1944 TO  
1974, THE SOCIAL WELFARE ACTS, 1952 TO 1974 AND 10  
THE EDUCATION (PROVISION OF MEALS) ACTS, 1914  
TO 1930.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:—

Old age pensions (new rates, extension of means limits).

	2.—(1) Section 77 of the Act of 1952 is hereby amended by—	
	(a) the substitution for subsection (2) (inserted by the Act of 1974) of the following subsection:	30
	“ (2) (a) A pension shall, in lieu of any other rate, be—	
	(i) where the weekly means of the claimant or pensioner do not exceed £15—at the rate set out in Table A to this subsection,	35
	(ii) where the weekly means of the claimant or pensioner exceed £15—at the rate at which, in accordance with that Table, the pension would be payable if the weekly means of the claimant or pensioner exceeded £14 but did not exceed £15, less £1 for each amount (if any) of £1 by which those weekly means exceed	40 45



£15, any fraction of £1 in those weekly means being treated for this purpose as £1; provided that if the rate calculated pursuant to this paragraph at which, but for this proviso, the pension would be payable is less than 50 new pence, the pension shall not be payable,

(iii) where the pensioner has attained the age of 80 years—at the rate of pension payable to him in accordance with subparagraph (i) or (ii) of this paragraph plus 70 new pence,

and the rate of pension so determined shall be increased, where the pensioner is one of a married couple, by the amount set out in Table B to this subsection—

(A) if the pensioner is a man, in respect of his wife if he is living with or wholly or mainly maintaining her and she is not in receipt of pension under the Acts or any benefit or pension under the Social Welfare Acts, 1952 to 1975, or

(B) if the pensioner is a woman, in respect of her husband if she is wholly or mainly maintaining him and he is incapable of self-support by reason of physical or mental infirmity and is not in receipt of pension under the Acts or any benefit or pension under the Social Welfare Acts, 1952 to 1975.

(b) For the purposes of this subsection, weekly means shall be the yearly means divided by fifty-two.

Widows' (non-contributory) pensions (new rates and extension of means limits).

5 “(1) (a) A widow's (non-contributory) pension shall, subject to the provisions of this Act, be—

(i) where the weekly means of the widow do not exceed £15—at the rate set out in Table B to this subsection, and

10 (ii) where the weekly means of the widow exceed £15 —at the rate at which, in accordance with that Table, the pension would be payable to the widow if her weekly means exceeded £14 but did not exceed £15, less £1 for each amount (if any) of £1 by which those weekly means exceed £15, any fraction of £1 in those weekly means being treated for this purpose as £1; provided that if the rate calculated pursuant to this paragraph at which, but for this proviso, the pension would be payable is less than 50 new pence, the pension shall not be payable.

20 (b) For the purposes of this subsection, weekly means shall be the yearly means divided by fifty-two.

30 5.—(1) For the purpose of applying the weekly rates specified in the Tables inserted by sections 2 and 4 of this Act (or in any Tables subsequently substituted for those Tables) to a case where the weekly means of the claimant or pensioner are or include means assessed in accordance with paragraph (I) of Rule 1 of the Rules as to Calculation of Means contained in the Seventh Schedule to the Act of 1952, the weekly means shall, subject to subsection (2) of this section, be taken to be increased by £1.

7.—(1) Section 6 (inserted by section 3 of the Social Welfare (Children's Allowances) Act, 1952) of the Children's Allowances (Amendment) Act, 1946, is hereby amended by the substitution for subsection (1) (inserted by the Act of 1974) of the following subsection:—

“(1) Subject to the provisions of the Social Welfare (Children's Allowances) Acts, 1944 to 1975, and of the regulations thereunder, a person who is found to be qualified for a children's allowance shall, so long as he remains so qualified, be paid out of moneys provided by the Oireachtas a monthly allowance at the rate of— 20

(a) £2.30 where he is qualified in respect of one qualified child,

(b) £5.90 where he is qualified in respect of two qualified children,

(c) £10.25 where he is qualified in respect of three or more qualified children, plus £4.35 in respect of each qualified child in excess of three.” 25

(2) This section shall come into operation on the 1st day of April, 1975.

Single woman's allowance (new rates and extension of means limit).

8.—(1) Section 8 of the Act of 1974 is hereby amended by the substitution of the Table to this section for the Table to that section. 30

(2) This section shall come into operation on the 3rd day of April, 1975.

(5) (a) A person who attains the age of 68 years on or after the 1st day of April, 1975, but before the 3rd day of January, 1977, may have his entitlement to old age (contributory) pension determined under the provisions of the Acts in operation prior to the 1st day of April, 1975, if that would be to his advantage. 40

(b) A person who has attained the age of 68 years before the 1st day of April, 1975, and has been awarded an old age (contributory) pension under the provisions of the Acts in operation prior to that date shall on and after that date have a right to such pension at the rate for the time being payable by reference to a yearly average of paid and credited contributions equal to the yearly average of paid and credited contributions calculated in his case under those provisions. 45 50

(c) Entitlement to a widow's (contributory) pension or deserted wife's benefit which is due to be determined by reference to the insurance record of a person attaining the age of 68 years before the 3rd day of January, 1977, may be determined under the provisions of the Acts in operation prior to the 1st day of April, 1975, if this would be to the advantage of the claimant. 55



(d) A widow or a deserted wife who under the provisions of the Acts in operation prior to the 1st day of April, 1975, has been awarded a widow's (contributory) pension or deserted wife's benefit on the basis of her own or her husband's insurance record at the date on which she or he attained the then pensionable age shall on and after the 1st day of April, 1975, have a right to such pension or benefit at the rate for the time being payable by reference to a yearly average of paid and credited contributions equal to the yearly average of paid and credited contributions calculated in her case under those provisions.

(e) In this subsection "the Acts" means the Social Welfare Acts, 1952 to 1975.

(6) This section shall come into operation on the 1st day of 15 April, 1975.

14.—(1) Section 6 of the Act of 1952 is hereby amended by the substitution for subsection (2) (inserted by the Act of 1960) of the following subsection :

“(2) Voluntary contributions shall be weekly contributions which shall be paid by voluntary contributors who are under pensionable age at the rate of— 20

(a) £0.83 for each contribution week where, immediately before ceasing to be employed contributors, they were



insurably employed in employment in respect of which the employment contributions payable are not reckonable for the purposes of old age (contributory) pension, and

5 (b) £2.17 for each contribution week where, immediately before ceasing to be employed contributors, they were insurably employed in employment in respect of which the employment contributions payable are reckonable for the purposes of old age (contributory) pension,

10 in the case both of male voluntary contributors and female voluntary contributors.”

(2) This section shall come into operation on the 7th day of April, 1975.

15 15.—(1) The Act of 1966 is hereby amended as follows :

(a) in section 8 (3) (a) “ £10.20 ” shall be substituted for “ eight pounds and forty new pence ” (inserted by the Act of 1974);

Social Welfare Acts, 1952 to 1975, or in any regulations made under any of those Acts, the Minister, with the consent of the Minister for Finance, may by regulations vary all or any of the rates of benefit, allowance, pension or assistance payable under any of those Acts.

(2) Regulations under *subsection (1)* of this section shall not so vary the rate of any benefit, allowance, pension or assistance as to reduce the amount of such benefit, allowance, pension or assistance payable at the commencement of the regulations.
