AN ACT TO AMEND SECTIONS 4, 37 AND 42 OF THE GAMING AND LOTTERIES ACT, 1956.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of Gaming and Lotteries Act, 1956.

- 1.—The Gaming and Lotteries Act, 1956, is hereby amended—
 - (a) in section 4, by the substitution of the following paragraph 10 for paragraph (c) of subsection (1):
 - "(c) by means of any slot-machine.",

and

(b) in sections 37 and 42, by the deletion, in each place where it occurs, of "a slot-machine prohibited by section 10 or". 15

Short title and collective citation.

- 2.—(1) This Act may be cited as the Gaming and Lotteries Act, 1979.
- (2) The Gaming and Lotteries Acts, 1956 and 1970, and this Act may be cited together as the Gaming and Lotteries Acts, 1956 to 1979.
