EXPLANATORY MEMORANDUM

The purpose of the Bill is to confirm the County Borough of Waterford (Extension of Boundary) Provisional Order, 1979. This Order was made by the Minister for the Environment on the 8th November, 1979 and is set out in the Schedule to the Bill. It arises from a petition from Waterford Corporation to extend their boundary and was made following the holding of a public inquiry.

The Order to be confirmed provides for the extension of the boundary of the County Borough of Waterford to include an area of County Waterford. The Order is expressed to come into operation on 1st January, 1980 or, in the event of the Confirmation Bill not being enacted by then, on such day as the Minister shall by Order appoint.

The Order contains consequential provisions of a standard nature. In view of differences in current rates, provision is made for gradual adjustment over a period of 3 years of liability for rates on property in the area being added to the County Borough of Waterford.
